4. Presentation of the Single Enrollment and Consolidated Enrollment Conceptual plans for the Westfield Elementary School Project for the MSBA PDP submission:
 Dan Pallotta stated that the purpose of the Preliminary Design Plan (PDP) is to define the programmatic functional, special, and environmental requirements of the educational facility to meet the District's Educational Program.

Jim Hannifan shared a PowerPoint presentation with the committee (attached). The presentation included a review of the Single Enrollment Options, Dual Enrollment Options, and Base Repair Options. It was noted that the City will not pursue the Base Repair Option but this option is a MSBA requirement.

Single Enrollment Options: 01A new building, 01B new building, 01C addition/renovation, 01D addition/renovation

Dual Enrollment Options: 02A new building, 02B new building, 02C addition/renovation, 02D addition/renovation

Base Repair Options: 03A base repair renovation

- Considering options for acquiring / developing residential abutters on Franklin Street



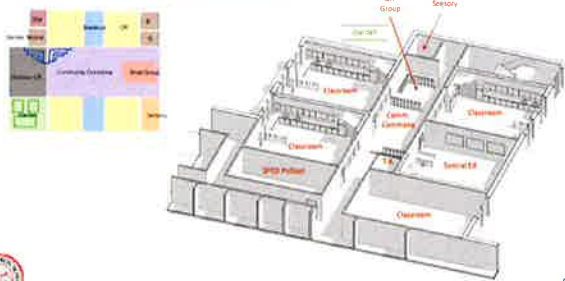
Whole School Diagram

- Classroom Neighborhoods w/ Outdoor Connections



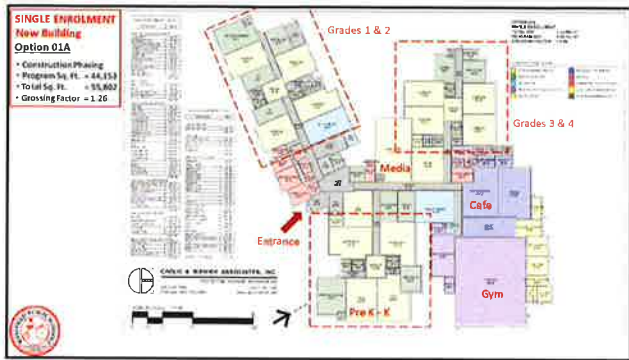
Classroom Neighborhood



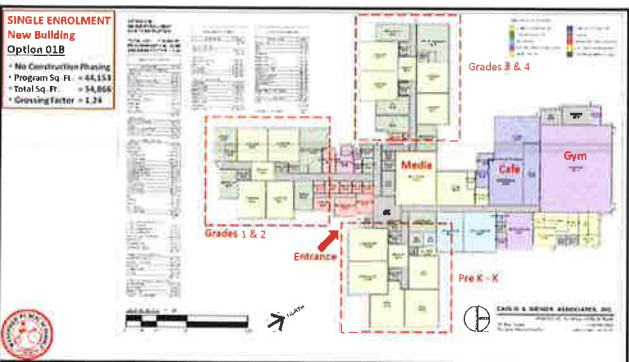

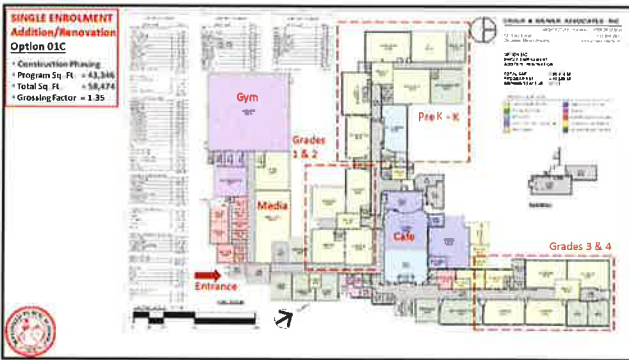

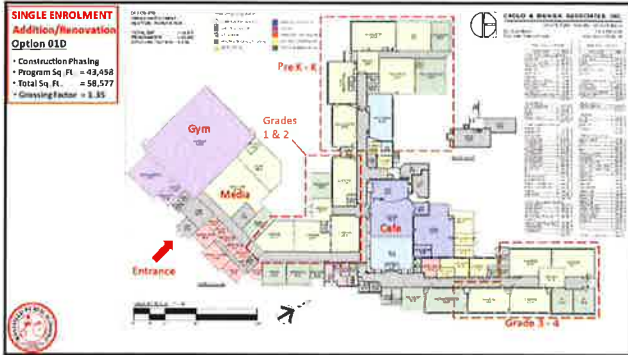
